- 3. the roles of the Ministry, the Workplace Safety and Insurance Board and other applicable entities designated under OHSA:
- 4. how to recognize, assess and control workplace hazards, and evaluate those controls;
- 5. sources of information on occupational health and safety.

METTLER TOLEDO will maintain employee completion records of Ontario's Basic Health and Safety Awareness Training provided to workers and supervisors as well as a record of those employees who are exempt from the training.
